- 2. Late bookings** Bookings made after 15 June, should include a late booking fee, as itemised on the form.
- 3. Concessionary Rate** Please don't stay away from conference because you have difficulties meeting the full registration fee. The concessionary rate is available to anyone on a low income. If you qualify, please use this facility.
- 4. Donations** Donations to SOF are applied in the first instance to its educational and development work including the provision of assistance to people on low income with the cost of attending the annual conference.

- 6. Cancellation Charges** 80% of the fee will be refunded for bookings cancelled by 31 May, 60% of the fee will be refunded for cancellations after that date and before 26 June, 40% between 26 June and 15 July and 20% on cancellations thereafter. Booking Conditions
